**Team Entry Fee is \$35.00 per team entered (Level 5 Placement Only).**

All Entry Fees must be paid in full at the time your club's entries are received!

**A) Check for Indiv. & Team entered, B) your club's USAG athlete membership list,**  
**C) your club's professional membership list (coaches), D) your club's T-Shirt**  
**Order Form and payment (See T-Shirt Order Form and letter).**

\* **LATE ENTRIES ARE \$25.00 PER ATHLETE** (New Rule – As Per USAG).

\* You may call and confirm the arrival of your entries.

- FORMAT:** This will be an **INDIVIDUAL and TEAM** oriented competition on Saturday and Sunday, and will be run in the **Modified Traditional Format** (warm up one event/compete that event, etc. through all four event rotations).
- The competition will follow the 2008-2009 USAG/Texas Rules and Policies.
- AGE GROUPS:** [Level 5 Placement](#) - JR. A, JR. B, JR.C, SR. A & SR. B
- \* **COACHES:** Please remind your individual Team parents not to call for competition times because of the large amount of telephone time required. Lone Star will make sure each gymnastics club that has athletes competing is notified and all correct and necessary information is posted on the Texas USAG Web site.
- BAR SETTINGS:** Bar settings may be obtained during the general stretch time prior to each session. Bar settings will be timed at approx. 30 seconds per athlete to ensure everyone gets a setting. Coaches, please be a little prepared for this!
- WARM-UPS:** Each gymnast will be given **1 minute (Level 5)** on both the bars and beam from the time the official timer starts the clock. All warm-ups will be timed and "block" timing by team **may be** used in all of the Pre-Competition timed Warm-Ups.
- EQUIPMENT:** Spieth Equipment on all apparatus and boards (Speith & AAI boards will be at Vault).
- \* All boards will stay on the apparatus assigned.
- COACHES MEETING:** There will be coaches meetings prior to each session during the general stretch time of each session. All packets, numbers, rotation sheets, etc. will be handed out at that time. Coaches will not receive their packets if ALL Entry Fees have not been paid in full and/or USAG athlete and/or coach membership registration numbers are missing.
- COMPETITION AREA:** Only team coaches, competing athletes, judges, and meet officials will be allowed on the competition floor. Please remind parents and non-competing team members of this rule.
- SCORES:** Scores from each session will be posted following the completion of each session.
- AWARDS:** There will be Individual and All Around awards presented to the athletes in each age division of each level following each competition session to the age groups that just competed. All Team awards will be presented at the end of the last session.
- PARKING:** There is ample parking on site. Please park only in marked spaces. (Thank You!)
- ADMISSION:** Admission will be [\\$7.00 per day](#) for adults and [\\$5.00 per day](#) for Senior Citizens and children under 12 years old. This Fee structure is set up by the USAG Texas State Board.

**CONCESSIONS:** Concessions will be available at all sessions for your convenience.
